* A state employee in Kansas who has specific information about a federal block grant being spent on



an unintended use or other use not specified in the block grant. * Special note the business could be located anywhere in Kansas including Overland Park, Topeka, Olathe, or Lawrence.

Come to us first, tell us what type of information you have, and if we think it's sufficient, we will help you with a focus on you getting rewarded."
