Burisma and NOV signed agreements for equipment supply and technical support. In particular, the first batch of equipment purchased by Burisma - TDS-11SA top drive - will be delivered to Ukraine in early 2018.

It is the most prolific top drive in the world today, capable of producing 800 HP, with 500 tons load capacity, offering a formidable 37,100 ft-lbs of continuous drilling torque at 110 RPM. The top drive will be installed on the SK-2000 rig at the Vodiansvske field and equipped with a Caterpillar generator set.
