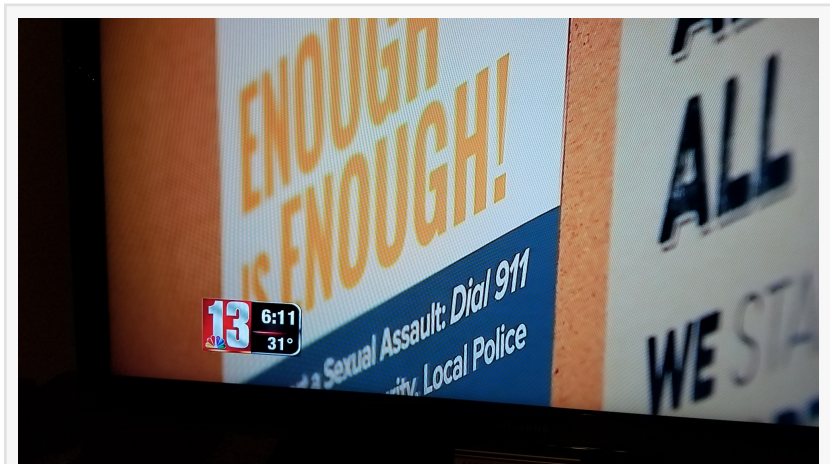

The Justice Center was formerly called the Commission on Quality of Care and Advocacy for Persons with Disabilities (CQC). It took Michael Carey a couple of years, following the death of his son Jonathan, who was killed in State care, to convince the New York Times to do this investigative reporting series. The CQC had decades of history of making almost all sexual assault and rape crimes of the disabled disappear and the governor simply renamed and relocated this same criminal enterprise to give a public appearance of reform. Cuomo's bogus Justice Center is a whitewash cover-up entity, it is the CQC on steroids, covering up well over a hundred times the cases of abuse, neglect and deaths than before.
