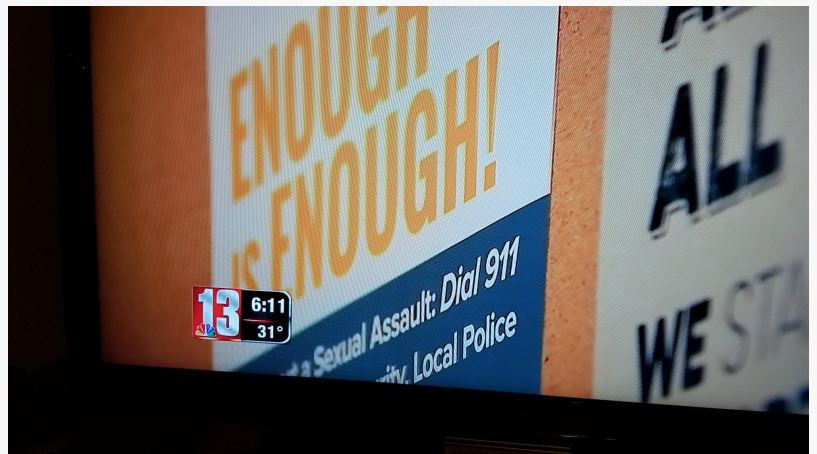


Gov. Cuomo Protects Sexual Predators & Pedophiles
