These are the State of New York's numbers for the Office of People with Developmental Disabilities (OPWDD). For you to understand the sheer magnitude of the rampant sexual abuse,

Then think about the reality that almost all sex crimes and rapes will never be witnessed or reported regarding people with developmental disabilities because they are the perfect victims for the sexual predators and <u>pedophiles</u> that prey on the vulnerable. These are innocent little boys and girls and women that are being sexually assaulted, raped, and sodomized, that are sexual assault victims that in most cases cannot speak or defend themselves.

The State of Massachusetts has placed on their official website a well recognized study and report called "Prevalence of Violence" that documents that only 3% of sexual assaults of people with developmental disabilities will ever be reported.

To get close to the real numbers of sexual assaults and rapes occurring in facilities and group homes,

again in only one of New York State's mental health agencies, OPWDD, you multiply the reported cases averaging 1,300 a year by 33 to get approximately 43,000 sex assaults or rapes annually, within a system of 126,000 people with developmental disabilities. Both Governor Cuomo and Cardinal Dolan know what is going on, yet they have done nothing significant to prevent or stop these sex crimes and sexual predators.

The numbers are mind boggling they are so big and you must be saying how can this be happening? There are many answers and they are all extremely disturbing. First, there are hardly any safety and abuse prevention measures in place to ensure safe care and services for the disabled in New York State. Second, the system is set up to internally report and police itself which everyone knows does not work. Almost all sex crimes are purposefully kept from 911 so local police and paramedics cannot respond. Third, people in top positions of authority do not care about what does or does not happen, what is important to them is the protection of large amounts of money and the protection of the institution from public shame.

Following the New York Times "Abused and Used" award winning investigative reporting series which Michael Carey convinced the Times to do, Governor Cuomo, for the last 7 years, has refused to take the significant actions vital to reform his system <a href="http://www.nytimes.com/interactive/nyregion/abused-and-used-series-page.html">http://www.nytimes.com/interactive/nyregion/abused-and-used-series-page.html</a>. Governor Cuomo has been able to successfully ensure the cover-ups of tens of thousands of sexual assaults and rapes of people with developmental disabilities. <u>Cardinal Timothy Dolan</u> has known of this for years and has done nothing. Michael Carey, over and over again reached out to Cardinal Dolan on behalf of the disabled for emergency help to only be shunned and ignored.
