According to Report, the [Global Bonding Films market](#) is expected to grow from \$632.41 million in 2016 to reach \$1218.14 million by 2023 with a CAGR of

9.8%. Growing demand from transportation and electrical & electronics industry, improvements in adhesive technologies, and robust properties than conventional adhesives are some of the factors boosting the market growth. In addition, raising adoption in wearable technology, growth in semi conductor industry are the other factors propelling the market growth. The growth is attributed to high adoption in electronic industry, strong adhesive properties than conventional substrates. Epoxy bonding films are more convenient to handle, and better performers in rugged environmental conditions. By the end user, electrical & electronics segment is anticipated to command the global market with highest growth rate over the forecast period.

North America represents the largest market in terms of revenue. The Asia Pacific region is expected to register higher growth rate owing to increasing adoption of technologies and raising capital investments from major companies. Moreover, ease of raw materials accessibility, high growth of electronics industry in emerging countries such as Japan, China, and South Korea are driving the market growth in Asia Pacific region.
