

High-risk work groups for exposure to asbestos in Michigan include US Navy Veterans, auto plant workers, power plant workers, manufacturing workers, plumbers, welders,

electricians, auto mechanics, machinists, or construction workers. Typically, these types of workers had significant exposure to asbestos during the 1950's, 1960's, 1970's, or 1980's.
