The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The oil & gas industry within the NAFTA countries had a total market value of \$344.4 billion in 2016.

The US was the fastest growing country, with a CAGR of -18.6% over the 2012-16 period.

Within the oil & gas industry, the US is the leading country among the NAFTA bloc, with market revenues of \$286.0 billion in 2016. This was followed by Canada and Mexico, with a value of \$32.3 and \$26.1 billion, respectively.

The US is expected to lead the oil & gas industry in the NAFTA bloc, with a value of \$406.1 billion in 2021, followed by Canada and Mexico with expected values of \$41.5 and \$31.2 billion, respectively.
