Who is eligible for the scholarship?

Qualifying individuals will be a high school senior or full-time college student, maintain a 3.0+ GPA, and reside in the U.S.

How does one apply for The Chart Westcott Scholarship?

Eligible students will be asked to submit a 500-word essay to The Chart Westcott Scholarship website answering the following question: "Describe your entrepreneurial idea and why you would make a great future entrepreneur or business leader."

When is the deadline to apply?

The deadline to apply for The Chart Westcott Scholarship for study in the fall of 2019 will be February 28th, 2019. The Foundation must notify the recipient of the grant no later than March 31st, 2019.
