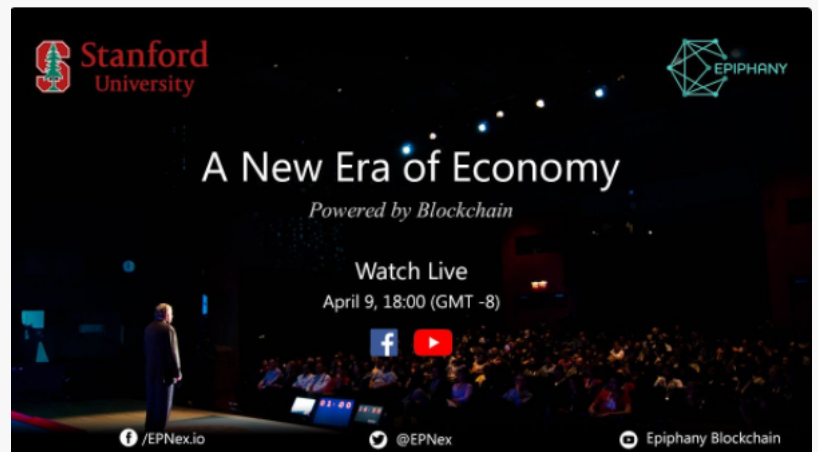
About A New Era of Economy:
