

Victim to DOJ and FTC: Enterprise and National Car Rental CONCEAL Video and Direct Police to WRONG Car to Cover Theft

Like Chipotle and the multi-million-dollar jury verdict, Enterprise Holdings National Rental engages in brazen cover up by failing to produce video surveillance

subpoena duces tecum, the docket contains images of the vehicle with subsequent damage that could not have happened at the time the victim returned the vehicle. <u>See the vehicle condition</u>, photographed at the crime scene and immediately emailed to the National Car Rental manger on duty. Compare the images with the photographs obtained via subpoena duces tecum and filed on the official Lee Court docket.
