

More Revelations Emerge: International Accreditation Forum (IAF) & ANAB Risk to American Interests & Deemed Anti-Semitic

For evil to succeed, all that the good men have to do is sit back and do nothing. That isn't the case with two patriotic Americans

A lot, as the ongoing saga of ANSI-ASQ National Accreditation Board (ANAB) and its accreditation body, [International Accreditation Forum](#) (IAF) reveals.

More details have recently emerged of the evil that lurks underneath the garb of quality accreditation bodies, IAF and ANAB. The first to signal the red flag was [Daryl Guberman](#) (<http://www.DarylGuberman.com>) an inspiring candidate for United States Senate (I-CT) and CEO of ABAC-accredited [G-PMC](#) Group, LLC. Guberman has been fighting a valiant battle against anti-American and anti-Semitic activities of these two organizations. He was recently joined by Donald LaBelle, Chairman, American Board of Accredited Certifications (ABAC). LaBelle is founder of VOB 9009 (<http://www.vob9009.com>), the nation's leading certification program for veteran-owned businesses.

The IAF is incorporated in Delaware as an American company. On digging underneath, Guberman found it to work as a China led company that is watching over American businesses in a vast array of industries, from aerospace, automotive and electronics to manufacturing and medical spaces. Guberman has now come out with evidence of the less than holy and anti-Semitic composition of IAF, and supporting him in the battle is LaBelle. For evil to succeed, all that the good men have to do is sit back and do nothing. That isn't the case with Guberman and LaBelle. LaBelle went on to expose IAF and ANAB in a hard hitting message. “We will not be part of an organization that ignores the State of Israel while supporting the terrorist

states of Iran and Palestine.”

The biggest red flag concerning IAF is its exclusion of Israel as either a member or signatory. The reason is not hard to fathom. IAF has on board around 11-12 Muslim countries, all of whom pay a fee to maintain their use of the IAF logo. Enlisting Israel would mean the loss of these member countries, leaving IAF with only Israel as a paying member.

“So IAF figured why get financial capital from just one country, Israel, when they can have these anti-Semitic countries on board, some of which, like Iran, want to see the destruction of the United States of America and Israel. That’s disgusting,” said Guberman.

An inquiry into IAF membership reveals its anti-Semitic undercurrents. North Korea was on board as a member and a signatory between 2002-2008, and Libya was on board between 2008-2017. They had their certificates taken away because of lack of payment. Under the ILAC/ARAC banner, we can see the listed regions and countries, including Palestine, Oman, Lebanon, Jordan, Morocco, Qatar, Yemen, Libya, or UAE, that are all majorly anti-Semitic. At IAF, they trade intellectual property. But they hold internet conferences, and could be up to any mischief, and Guberman has that information.

It is not merely the anti-Semitic nature of IAF that is problematic. LaBelle and Guberman have also expressed deep concern about its leadership, with a Chinese national at the helm as the CEO of IAF since 2015. In an earlier public message, Guberman pointed out the dangers involved in this. American companies are running the risk of being controlled and victimized by a China led organization that could easily get hold of sensitive documentation and quality management systems.

Aiding IAF in its nefarious activities are government and federal officials, corporate executives, and tax funded organizations. The IAF according to Guberman is more of a ponzi scheme, engaged in expanding its reach and influence by using the bogus cover of a quality accreditation organization.

LaBelle has an even stronger message to send out. “Tell me, as an American company, is your allegiance to the United States or China? Do you support American workers and families? If so, why in the hell would you want your ISO registration to be issued by a registrar belonging to China?”

Guberman’s efforts are inspired by a deep conviction that there is nothing that hurts any government than internal espionage, internal degradation of a country under the guise of quality. Only truth can set us free.

As of IAF and its constituent anti-Semitic members, Guberman believes a leopard cannot change its spots. He quotes Thomas Paine, the 18th century humanist and thinker, “When a man has so far corrupted and prostituted the chastity of his mind, as to subscribe his professional beliefs to things he does not believe, he has prepared himself for every other crime.”
