The couple plans to marry at the Irvine Ranch Historic Park (Jamboree Road and Irvine Boulevard) which is where the original Irvine family home was and is now the Katie Wheeler Library (named after James's Aunt). James was born and raised in the home as a young boy. He will be the last Irvine that lived in the mansion, who will be married there.

Susan was crowned Ms. America® 1997 at the Luxor Hotel in Las Vegas winning \$75,000 in cash and prizes. Some of her other titles include: Miss Orange County 1987, Miss Brea/Fullerton 1986 and Ms. California State 1996. In 1999 she purchased the Ms. America® Pageant and became its CEO. Since then she has grown the pageant into an institution that attracts high-achieving women from all walks of life to vie for the title and put it to philanthropic use. In 1993, Jeske set
