The company will keep the same successful team and will be adding staff that will achieve the desired strategic growth. Terms of the deal, handled by Cohen & Grigsby, were confidential.

Founded in 1999, INTEG later received an investment from Innovation Works that was beneficial to their early product development and penetration into their first market segment, the theater industry. The company has ever since played a key role in the [digital cinema](#) transformation. The [JNIOR](#) (pronounced "junior") automation controller is currently used by over a third of the movie theaters in the world. Between the cinema market and other industries using the JNIOR, INTEG has shipped products in volume to over 400 customers in over 50 countries.

According to Rick Shulkosky, INTEG's President, "INTEG has created a highly successful and extremely flexible automation controller that has dominated the digital cinema market. With Bruce's deep technical knowledge of the product and financial backing, we are looking forward to moving into additional markets."

According to Bruce Cloutier, INTEG's CTO and now sole owner, "developing the fourth generation of the JNIOR over the past several years has allowed me to leverage techniques and technology that I have learned during my career. The JNIOR implements a number of unique features for a controller its size including the ability to handle secure connections. The product works 'as-is' right out of the box, but also has the ability to have custom software applications easily added by the user to focus its use. I am looking forward to driving INTEG's growth and introducing the JNIOR to the broader IoT market."
