The global Anti-Counterfeiting Packaging market is valued at 180400 million USD in 2017 and is expected to reach 272000 million USD by the end of 2023, growing at a CAGR of 7.1% between 2017 and 2023.

The Asia-Pacific will occupy for more market share in following years, especially in China, also fast growing India and Southeast Asia regions.
