That way, after a little digging, you can decide based on the lawyer's past cases and clients.

Shop Around

Retaining a lawyer is a big decision. So, Analise Tenney insists that how lawyers look on paper isn't end all, be all. There's still a consultation that must be done after you've narrowed down your options.

Think of it as getting a second and third opinion. While the lawyer's approach and reputation might be admirable, they still might not be the lawyer for you.

Tenney stresses that as a client, you must trust your lawyer implicitly. If you aren't comfortable speaking to your lawyer in a consultation, you won't be comfortable telling him details about yourself. That's a problem since it's in your best interest, to be honest, and upfront with your lawyer.

That's the only way your lawyer can accurately represent you.

Put Their Skills to Work

The next step to finding a lawyer, according to Analise Tenney, is putting their skills to work. After you've narrowed down the list of lawyers, the following action is to negotiate a price.

Now, getting the best deal is a good motivator, but Tenney said when dealing with lawyers, focus more on them. This is where you get a preview of how they make a case. Since it's for themselves, they should be passionate about it. If they give in too easy, or they react in an off-putting manner, they're not the lawyer for you.

If you're impressed by the way they handle themselves, and you're convinced by their price quote, you've likely found a winner.
