

## Following £2 billion loan facility issue Macquarie to discuss sustainable infrastructure at Benelux Infrastructure Forum

After issuing a £2 billion loan facility, Macquarie Group are set to present at Benelux Infrastructure Forum on infrastructure and sustainable energy projects.
