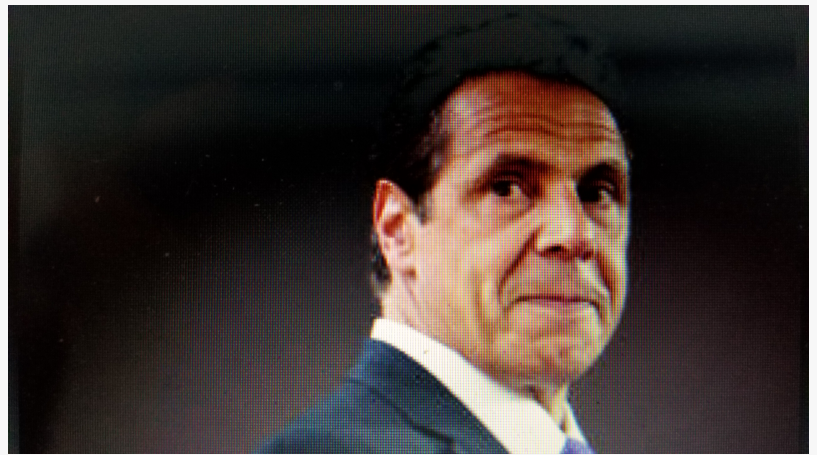


Gov. Andrew Cuomo Directing Federal Crimes

The third motive is to ensure that most crimes against the disabled are never documented as crimes so that Cuomo can save massive amounts of money by not paying out crime victim benefits to the disabled victims or their families. Raping children and women with disabilities are crimes. Overmedicating or restraining a person to death is a criminally negligent homicide. Physically assaulting incompetent and physically disabled people are crimes. Governor Andrew Cuomo is making thousands of these crimes disappear and he is protecting countless [sexual predators](#) and pedophiles within his agencies.

Cuomo ignored the countless calls for basic reforms to finally protect people with disabilities by well known and respected civil rights and disability rights advocate, Michael Carey, and then by the New York Times.
