The Attorney General's office is also tasked with ensuring civil rights, yet there is no evidence that the New York State

Attorney General is doing this in any capacity for crime victims within the State's extremely dangerous mental health care system. People with disabilities are human beings, equal human beings that have constitutional rights. Both the New York State and United States Constitutions promise everyone 'equal protections of the laws', but the discrimination and blatant denying of these individuals rights continue.

Attorney General Barbara Underwood has the responsibility to protect the people of New York State and to honor her oath of office. Instead, AG Underwood is protecting Governor Andrew Cuomo and other top officials that are ensuring most crimes committed against the disabled never get to 911 call systems, the police and county elected District Attorney's, so they cannot be prosecuted. Tragically, Miss Underwood has failed the most vulnerable and has assisted in the

criminal cover-ups, the civil rights atrocities and the Medicaid fraud ponzi scheme.

Michael Carey, the founder of the Jonathan Carey Foundation and a well respected civil rights and disability rights advocate has publicly called for AG Underwood to immediately resign.
