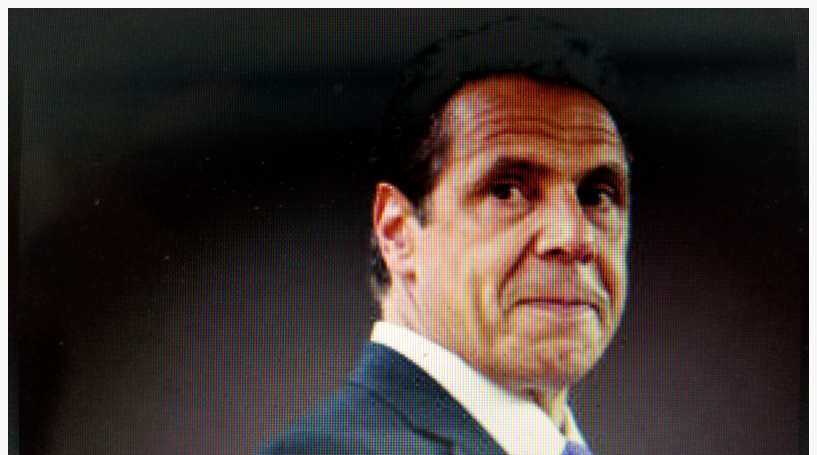


Gov. Cuomo and AG Underwood allowing known sexual offenders in with the developmentally disabled
