China has been an established exporter of green tea and accounts for over 60% of green tea exports worldwide, followed by Japan, Sri Lanka, India, and Indonesia. Companies such as Guilin Layn Natural Ingredients Corp. and Hunan Sunfull Bio-Tech Inc produce the majority of green tea extract in China.

Exports may decrease as production has fallen in countries such as India, Sri Lanka and Kenya. Since, the effects of global warming have already started to show, the production of tea may have to shift to newer locations in the coming decades.

Morocco leads the worldwide imports for green tea, followed by the United States, Germany, and France and so on. Companies such as Amax NutraSource (United States), Naturex (France), Prinova (United States) and so on produce the majority of green tea extract outside of Asia and Africa. Imports will fall if production falls in the Asian and African countries and the countries which currently import green tea may have to produce it in-house in the future depending upon the changing weather conditions. Due to the global warming effects, the production of green tea would ultimately go down to the countries with suitable soil and temperature for cultivation and can afford to substitute growing tea.

If green tea production shifts to new areas, people will also encounter changes in supply chain costs, owing to factors, such as fuel costs for transportation. Countries such as China, Japan and India will lower their exports and other countries such as Turkey or Australia may increase their production. However, the implications of greenhouse gases on imports and exports are still uncertain, as there are other factors to consider, such as a sudden spread of pests and rodents or unexpected natural disasters that can render the area. Producers of tea could look to create new hybrids that would grow regardless of the changes in temperature and rainfall.
