"The lack of supervision there made it easy to do what I did," DeProspero said in a handwritten affidavit obtained by The Associated Press. "I could have stayed in that house for years and abused him every day without anybody even noticing at all. It was a predator's dream."

It is [Governor Andrew Cuomo](#) that has directed the protection sexual predators like DeProspero. The only reasons for AG Underwood to look the other way would be to protect Governor Andrew Cuomo and the Medicaid fraud Ponzi Scheme. Almost all reported sex crimes of the disabled are covered-up by Governor Andrew Cuomo's corrupt Justice Center. Gov. Cuomo can change the way he thinks at anytime, the sooner he does, most of the rapes and cover-ups will be stopped.
