



Opeds Fortas Precedent on Kavanaugh, Booker's Missed WH Prison Reform Op, Prosecute Flint Decidrs by Fmr WH Spsmn

Former WH spokesman Robert Weiner and his team have just published three op-eds, in the Memphis Commercial Appeal, the New Jersey Star Leger, and Labor Press.

The first, ranked H1 by OpEdNews as the top op-ed in the country, was originally published in the Memphis Commercial Appeal by Weiner and Emilie Solberg on how the precedent set by Rob Fortas, who resigned as Supreme Court Justice in 1969 could repeat itself with Brett Kavanaugh's process now scrutinized by the new House Judiciary Committee. The second, by Weiner and Jared Schwartz, in the NJ Star Ledger and ranked H3 in OpEdNews, is on why Corey Booker should show bipartisanship on criminal justice reform and not skip White House meetings, as he did this week, if he wants to establish a record for a presidential campaign. The third, in Labor Press, ranked H2 as nation's #2 op-ed, calls for prosecution of public officials causing abusive decisions including Flint water and child immigrant cages. He also appeared on Sky News twice in the week leading up to the midterms and once on midterm night. He also appeared on the Dave Elliott Show (SW FL #1 news-talk radio show) the morning after the midterms. Weiner also asked a question on C-Span on economic equity to "Ben & Jerry" at a news conference at the National Press Club that viewers said this week as relevant today, so included.
