This section includes the following key indicators:

1. The share of direct cryptoasset

transactions, displayed as a percentage

of blockchain-based transactions compared to all cryptoasset transactions.

2. The share of all direct blockchain transactions. Calculated based on the amount of all confirmed blockchain transactions in the analyzed period of time.

3. Sum of transactions in USD, which shows the fiat equivalent of all verified blockchain-based transactions of a given cryptoasset in the analyzed period of time.

4. Volume of cryptoasset transactions in USD, which shows the fiat equivalent of blockchain transactions to USD in the analyzed period of time.

5. Average transaction in USD. Ćalculates the fiat equivalent of the average blockchain-based cryptoasset/USD transaction in the analyzed period of time.

6. The percentage of transactions of total cryptoasset emission. Calculated based on the percentage of the volume of blockchain-based transactions compared to total emission of the cryptoasset.

7. Cryptoasset transactions rating, which shows the usage frequency and the share of blockchain-based transactions of the cryptoasset being analyzed, compared to all cryptoassets.

These key indicators are formed and calculated in accordance with a real-time analysis of all cryptoassets.
