Mr. Haralambopoulos pointed to a report by the Insurance Research Council that studied car accident claims. Some of the injured people were represented by an attorney and some not. The Consumer Panel Survey of [Auto Accident](#) Victims says people with an attorney get 40 percent more in a settlement than those without an attorney.

"Someone is going to point to this and say, 'but the attorney gets a share of the settlement.' That is true. Most attorneys do receive one-third of the settlement. One third is less than 40 percent," he said. "You still get more money with an attorney than you can without an attorney."

In addition, the attorney is only paid if the case is won. If the person injured does not get any settlement, the lawyer gets no money. Accident claims are handled on a contingency basis.

"The short of it is, we have to work to get paid. The harder we work, the more you get in a cash settlement and the more we get," he said.
