announced that 12 health systems, representing approximately 250 hospitals across the United States, have joined the new not-for-profit generic drug company as founding members. When combined with hospitals represented by the initial governing members of Civica Rx, approximately 750 U.S. hospitals have joined the mission-driven venture so far, with many more health systems expressing interest.

Civica Rx was established in 2018 by three philanthropies and seven leading health systems that experience first-hand the impact of drug shortages, which have become all too common and affect all aspects of the health care delivery system. The highly-collaborative initiative will

result in lower costs and more predictable supplies of many medicines, helping ensure that patients and their needs come first in the generic drug marketplace.

Civica Rx members drive drug selection decisions to ensure Civica Rx manufactures the medications that are most essential to patient care. The 12 new founding members include:

Civica Rx expects to bring over 14 hospital-administered generic drugs to hospitals and health

care systems in 2019 as the initial focus of the company's efforts, with many additional medications prioritized by the healthcare systems as the next phase of focus. The company is working towards becoming an FDA approved manufacturer and will either directly manufacture generic drugs or sub-contract manufacturing to trusted supply partners.
