NEXUS SERVICES, INC. RESISTS NY ATTORNEY GENERAL'S DATA GRAB OF SENSITIVE IMMIGRANT PERSONAL INFORMATION

In response to the New York Attorney General's motion to hold Nexus Services in contempt of court, the company's CEO Mike Donovan vows to protect clients' data from the Trump deportation machine, and vows to do so at all costs.

New York, NY., January 10, 2018 - Today, in the matter of Libre by Nexus pending in the Supreme Court of NY (Manhattan division), attorneys for the company will fight the NY Attorney General's reckless attempt to seize personal immigrant data they don't need, and according to their own pleadings in the Southern District of NY, data they also cannot protect.

The NY AG filed a motion to hold the company in contempt of court. Mike Donovan, Nexus' CEO, said "The New York Attorney General appears to be more interested in scoring cheap political points than in protecting a vulnerable immigrant community. Their own filings in State of New York v. United States Department of Justice admit that they are powerless to stop the Trump administration from seizing any immigration data they have on their citizens". In spite of this, the AG is attempting the single largest data grab of personal data of immigrants in removal proceedings in the history of the United States.

Donovan said "We made a commitment to our clients to protect their confidential data, and we will do so at any and all cost. Protecting our clients' personal information is far more important to my company and me than any amount of money or event protecting my personal freedom or the good graces of political hacks who by day pretend to care about vulnerable immigrants but

who then by night defend corrupt jail and prison officials who assault them or trample their rights. The hypocrisy of the New York Attorney General is on display for all to see, and Nexus will hold the line against their attempt to harm our clients.”
