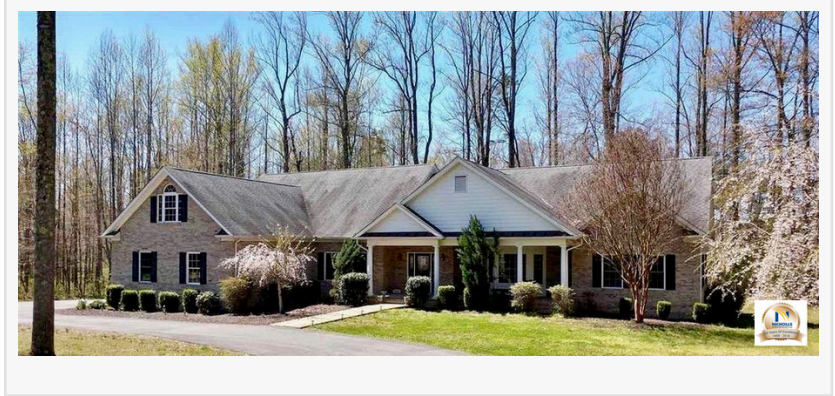


Bidding Set to Close on Immaculate Albemarle County Virginia Brick Home
