for recovery of underinsured motorist benefits. The insurer refused to pay, claiming that her pain and the addiction resulted from pre-existing conditions and trauma. Haggerty would not accept the insurance company's refusal to pay his client.

"My client deserved the underinsured motorist benefits that were being denied," Haggerty said. "Her addiction was not her fault. She deserved to be compensated for the

injuries and the consequences."

Shortly before trial in Federal Court, <u>Jim Haggerty</u> secured a favorable settlement for his client. HGSK continues to protect the rights of consumers and accident victims in Pennsylvania.
