

High-risk work groups for exposure to asbestos In California include US Navy Veterans, power plant workers, shipyard workers, oil refinery workers, chemical plant workers, manufacturing

workers, plumbers, electricians, auto mechanics, machinists, or construction workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.

According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.
