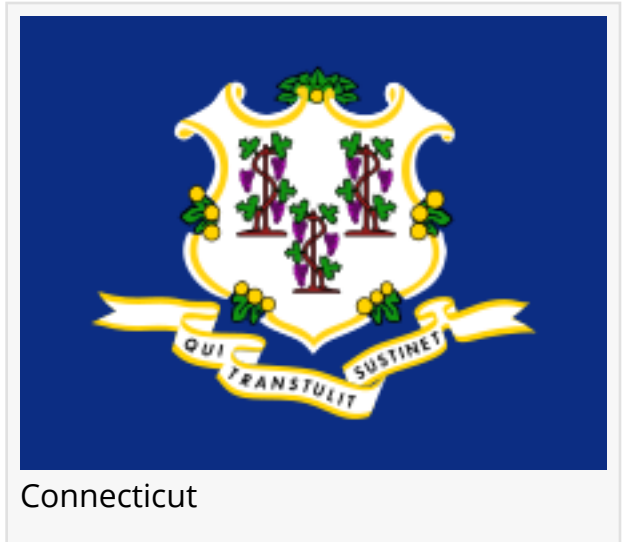

High risk work groups for mesothelioma in Connecticut include US Navy Veterans or shipyard workers in New London/Groton, or workers at a power plant, at an industrial facility, at a manufacturing facility, at a public utility, as a plumber, welder, a boiler technician, as an auto repairman, as an electrician, or in the construction industry. In most cases, the exposure to asbestos caused mesothelioma at one of these types of workplaces and the exposure took place in the 1950's, 1960's, 1970's, or 1980's.
