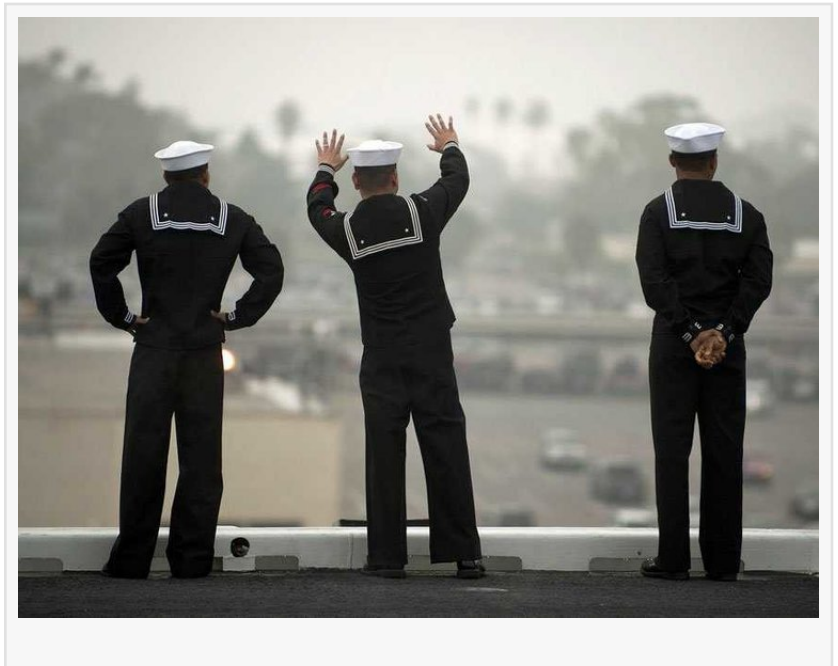

The states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon. However-mesothelioma does happen in Utah.

High-risk work groups for exposure to asbestos in Utah include US Navy Veterans, oil refinery workers, public utility workers, power plant workers, plumbers, pipefitters,

electricians, auto mechanics, machinists, or construction workers. In most instances a diagnosed person with mesothelioma was exposed to asbestos in the 1950's, 1960's, 1970's, or 1980's.
