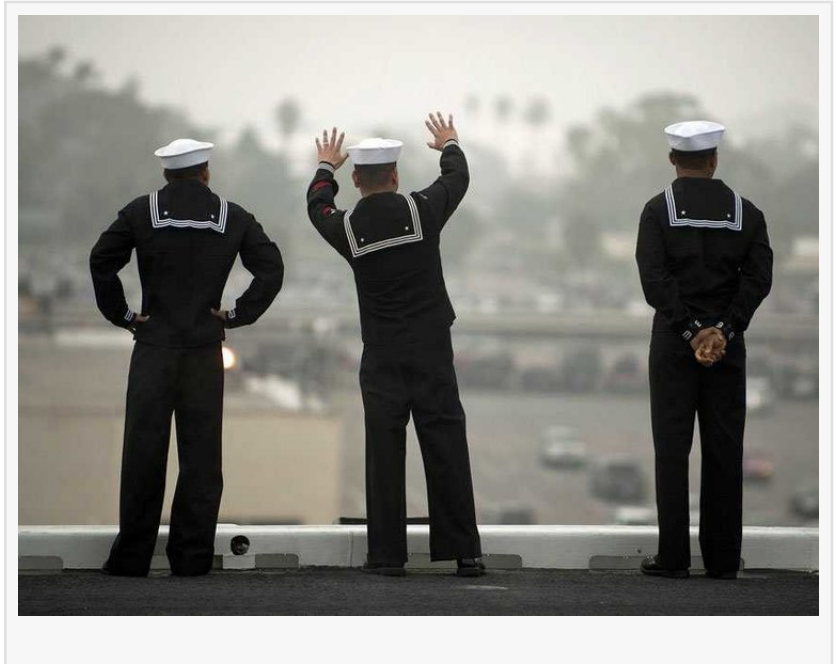

High-risk work groups for exposure to asbestos in Ohio include Veterans of the US Navy, civilian workers at Wright Patterson Air Force Base, workers at one of Ohio's dozen plus power plants, auto assembly plant workers, automobile tire factory workers, public utility workers, plumbers, welders, millwrights, insulators, pipefitters, electricians, coal miners, auto mechanics, machinists, and construction workers. Typically, exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's. www.karstvonoiste.com/



According to the American Cancer Society for nonsmokers who have been exposed to asbestos in their workplace the risk of lung cancer is five times that of unexposed workers.
