

Minnesota US Navy Veterans Lung Cancer Advocate Urges a Navy Veteran or a Person with Lung Cancer in Minnesota To Call the Lawyers at Karst von Oiste About Compensation-If They Had Significant Asbestos Exposure

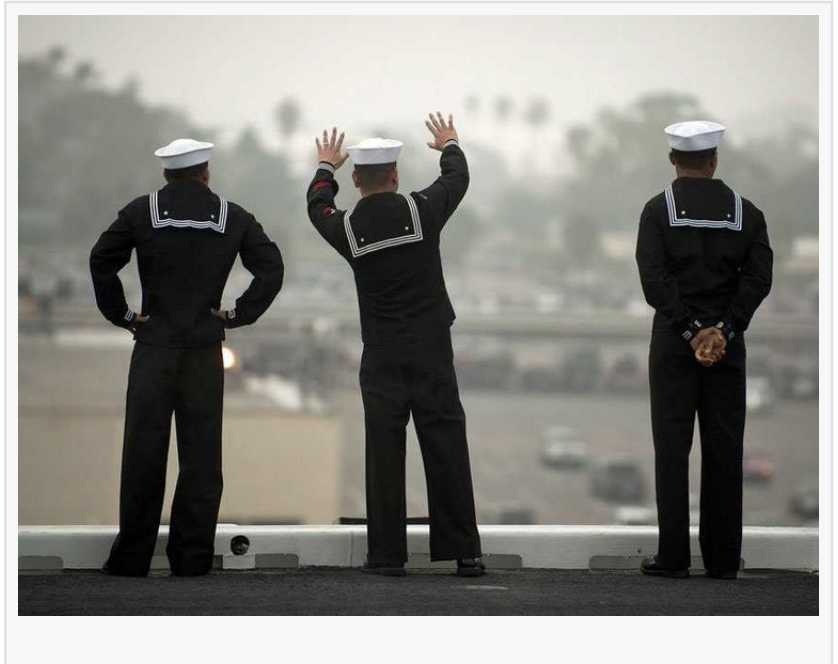

Compensation for a person like this might exceed \$100,000-and the financial compensation claim does not involve suing the navy.



"We are also appealing to the family of a Navy Veteran or person who now has lung cancer and who had significant exposure to asbestos on a navy ship, submarine, or shipyard to please tell their loved one about the potential for financial compensation and to ask them to call the lawyers at Karst von Oiste at 800-714-0303 to assist. The lawyers at the law firm of Karst von Oiste have been assisting Navy Veterans and people with asbestos exposure lung cancer and mesothelioma for decades and they are responsible for over a billion dollars in compensation for people like this. What most Navy Veterans or people who now have lung cancer-and who had

significant exposure to asbestos prior to 1982 do not realize is the \$30 billion dollar-asbestos trust funds were set up for them too."

High-risk work groups for exposure to asbestos in Minnesota include Veterans of the US Navy, a worker at one of dozens of power plants in Minnesota, factory workers, welders, millwrights, pipefitters, industrial workers, public utility workers, plumbers, electricians, boiler technicians, auto mechanics, machinists, iron ore miners, and construction workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's. www.karstvonoiste.com/

States with the highest incidence of lung cancer include Kentucky, West Virginia, Maine, Tennessee, Mississippi, Ohio, Indiana, Louisiana, Arkansas, Missouri, North Carolina, Rhode

Island, Alabama, and Delaware.
