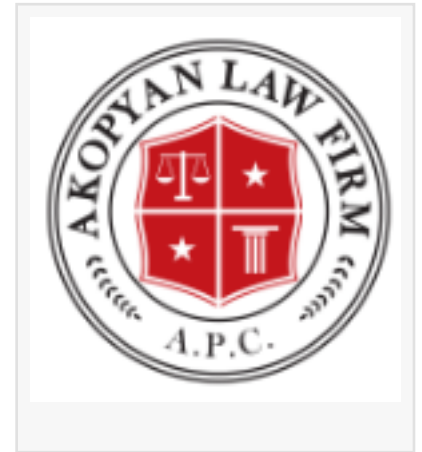

"A traumatic brain injury (TBI) is a disruption in the normal function of the brain that can be caused by a bump, blow, or jolt to the head or penetrating head injury," a spokesperson said. A TBI can be mild (like, for example, when there is a brief change in mental status) or severe (where there is an extended period of unconsciousness or amnesia after the injury). Those who suffer TBI often require specialized treatment. Oftentimes they are unable to live their lives as they did before the accident or injury-causing event.

Trauma to the brain damages the brain's structure and prevents it from functioning in a normal way. The Centers for Disease Control and Prevention (CDC) notes that TBI can affect the way a person: thinks (memory and reasoning); experiences sensations (such as touch, taste, and smell) communicates with others (speaking and understanding); controls his or her emotions (as well as social interactions). TBI can affect all aspects of an individual's life, including relationships with family and friends, the ability to progress at school or work, doing household tasks, driving, or participating in other daily activities

"We understand the impact that TBI can have on the lives of not only victims but also their families," the spokesperson stressed, before adding, "If someone else's negligence caused you to suffer a traumatic brain injury, we stand ready to fight for you and to hold the responsible party (or parties) accountable.
