High-risk work groups for exposure to

asbestos in New Jersey include US Navy Veterans, a worker at one of New Jersey's half dozen plus power plants, oil refinery workers, manufacturing or industrial workers, chemical plant workers, public utility workers, plumbers, electricians, auto mechanics, machinists, mill workers,

New Jersey US Navy Veterans Lung Cancer Advocate printers, welders, boiler technicians, or construction workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's or 1980's.


were set up for them too. We are trying to change this sad fact." <u>https://USNavyLungCancer.Com</u>

According to the American Cancer Society for nonsmokers who have been exposed to asbestos in their workplace the risk of lung cancer is five times that of unexposed workers. <u>https://www.cdc.gov/cancer/lung/statistics/index.htm</u>.

States with the highest incidence of lung cancer include Kentucky, West Virginia, Maine, Tennessee, Mississippi, Ohio, Indiana, Louisiana, Arkansas, Missouri, North Carolina, Rhode Island, Alabama, and Delaware. However, asbestos exposure lung cancer can happen in any state including California, New York, Texas, Florida, Massachusetts, Connecticut, Pennsylvania, New Jersey, Illinois, Wisconsin, Minnesota, Nebraska, New Mexico, North Dakota, Wyoming, Utah, Montana, Idaho, Arizona, Washington, Oregon or Alaska. <u>www.karstvonoiste.com/</u>
