

South Carolina US Navy Veterans Lung Cancer Advocate Urges a Navy Veteran with Lung Cancer in South Carolina to Call the Lawyers at Karst von Oiste if He Had Navy Asbestos Exposure-Compensation May Exceed \$100,000

is over 60 years old-and it does not matter if they smoked cigarettes.

"Most Navy Veterans may have heard about financial compensation for mesothelioma-but most are not aware that the \$30 billion dollar-asbestos trust funds were set up for them too. High risk work groups for exposure to asbestos in South Carolina include US Navy Veterans, civilian employees Charleston Navy Base, a worker at one of South Carolina's dozen+ power plants, at a industrial facility, a worker at one of South Carolina's half dozen pulp and paper mills, a public utility worker, or as a plumber, a boiler technician, welder, as a auto repairman, as a electrician, or in the construction industry.
