

# Investors of OrthoPediatrics With Losses Greater Than \$50,000 Encouraged To Contact Kehoe Law Firm, P.C.

*Securities Class Action Investigation On Behalf Of Shareholders Of OrthoPediatrics Corp.*

On this news, the stock price of OrthoPediatrics fell \$4.12 per share, or 9.13%, to close at \$41.02 per share on December 2, 2020.
