


Oklahoma US Navy Veterans Lung Cancer Advocate Appeals to The Family of a Navy Veteran with Lung Cancer in Oklahoma to Call Attorney Erik Karst if He Had Navy Asbestos Exposure-Compensation May Exceed \$100,000

"We could not say this enough times----the \$30 billion dollar-asbestos trust funds were set up for people who had heavy exposure to asbestos in the navy or at work and who then develop




lung cancer. If this sounds like your husband or dad-please call attorney Erik Karst of the law

High risk occupations for asbestos exposure in Oklahoma include US Navy Veterans, Fort Sill Army Base in Lawton, Tinker Air Force Base in Oklahoma City, and the U.S. Naval Ammunition Depot in McAlester, oil-gas production workers, power plant workers, public utility workers, oil refinery workers, plumbers, electricians, welders, machinists, millwrights, mechanics, auto brake technicians, construction workers.
