High risk work groups for exposure to asbestos in South Carolina include US Navy Veterans, civilian employees Charleston Navy Base, a worker at one of South Carolina's dozen+ power plants, at a industrial facility, a worker at one of South Carolina's half dozen pulp and paper mills, a public utility worker, or as a plumber, a boiler technician, welder, as a auto repairman, as a electrician, or in the construction industry. Typically, the exposure took place in the 1950's, 1960's, 1970's, or 1980's.

According to the American Cancer Society for nonsmokers who have been exposed to asbestos in their workplace the risk of lung cancer is five times that of unexposed workers.
