

Industry Experts to Discuss Direct EB-5 Investor Source of Funds for EB-5 Investors in the Middle East

While it is clear that USCIS wants higher minimum investment amounts, it is unclear when direct EB-5 investments might return to the \$900,000 minimum.

Silverman emphasized that investors shouldn't wait. "Anyone thinking of making an investment needs to take steps now to get their funds in place and begin the source-of-funds documentation process. The window of opportunity to <u>invest at \$500,000</u> is closing even faster than many had guessed. Time is short."
