

CLS Holdings USA, Inc. Announces New Brand Manager, Dani Baranowski, for The Company's Branded Division, City Trees

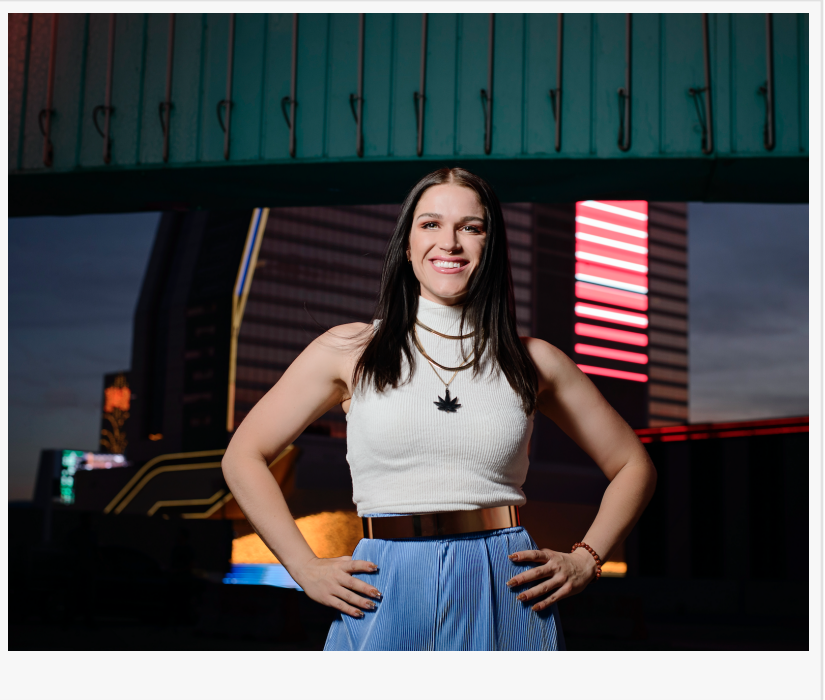
