

The Advocate Urges a Navy Veteran Who Now Has Lung Cancer in Arizona to Call Attorney Erik Karst of Karst von Oiste if Before 1982 He Had Navy Asbestos Exposure-Compensation Might Exceed \$100,000

PHOENIX , ARIZONA , USA, February 17, 2022 /EINPresswire.com/ -- The Arizona US Navy Veterans Lung Cancer Advocate is urging a Navy Veteran anywhere in Arizona who has recently learned they have lung cancer to please call attorney Erik Karst of the law firm of Karst von Oiste at 800-714-0303 if before 1982 they had significant exposure to asbestos on a navy ship, submarine or at a shipyard. Financial compensation for a person like this might exceed \$100,000, the claim does not involve suing the navy and it does not matter if the Navy Veteran smoked cigarettes. What does matter is the Veteran can recall how they were exposed to asbestos in the navy.

The Advocate says, "The biggest mistake a Navy Veteran who now has lung cancer and who had significant exposure to asbestos on a ship, submarine or at a navy shipyard is to think they will not qualify for compensation because they once smoked cigarettes. Most people like the person we have just described never get compensated because they are not aware the \$30 billion dollar asbestos trust funds were set up, for them too.

Individuals in the state of Arizona could have been exposed to asbestos while working at a power plant, at an industrial facility, at a steel mill, at an automobile manufacturing facility, at



a chemical plant, as a plumber, a boiler technician, as an auto repairman, as an electrician, or in the construction industry. In most cases, the exposure to asbestos caused mesothelioma at one of these types of workplaces and the exposure took place in the 1950's, 1960's, 1970's, or 1980's. Mesothelioma or asbestos exposure lung cancer typically takes three to five decades to appear.

According to the American Cancer Society for nonsmokers who have been exposed to asbestos in their workplace the risk of lung cancer is five times that of unexposed workers. https://www.cdc.gov/cancer/lung/statistics/index.htm.

States with the highest incidence of lung cancer include Kentucky, West Virginia, Maine, Tennessee, Mississippi, Ohio, Indiana, Louisiana, Arkansas, Missouri, North Carolina, Rhode Island, Alabama, and Delaware. However, there are people with asbestos exposure lung cancer
