

The Advocate Urges a Navy Veteran with Recently Diagnosed Lung Cancer in Indiana to Call Attorney Erik Karst of Karst von Oiste if Before 1982 He Had Navy Asbestos Exposure-Compensation May Exceed \$100,000

INDIANAPOLIS, INDIANA, USA, April 7, 2022 /EINPresswire.com/ -- The Indiana US Navy Veterans Lung Cancer Advocate says, "If your husband or dad is a Navy Veteran with recently diagnosed lung cancer anywhere in Indiana, please call attorney Erik Karst of the law firm of Karst von Oiste at 800-714-0303 if before 1982 he had significant exposure to asbestos while serving on a navy ship, submarine or at a navy shipyard. A financial compensation settlement for a person like this might exceed \$100,000 and the claim does not involve suing the navy.



"A compensation claim like this involves the makers of pipes, pumps,

valves, gaskets, equipment, or machinery that contained asbestos. Most Navy Veterans who have recently developed lung cancer and who prior to 1982 had navy asbestos exposure do not realize the \$30 billion dollar asbestos trust funds were set up for them too.


"If your loved one is a Navy Veteran who has just been diagnosed with lung cancer, and who had navy asbestos exposure before 1982 please call attorney Erik Karst of the law firm of Karst von Oiste at 800-714-0303. To get compensated the Navy Veteran must be able to recall the specifics

of how they were exposed to asbestos prior to 1982." www.karstvonoiste.com/

High-risk work groups for exposure to asbestos in Indiana include US Navy Veterans, workers at one of Indiana's 20+ power plants, oil refinery workers, steel mill workers, manufacturing, or



industrial workers, coal miners, public utility workers, plumbers, electricians, auto mechanics, machinists, or construction workers. In most instances. the diagnosed person's exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's. www.karstvonoiste.com/
