To qualify for compensation the person with lung cancer must have been exposed to asbestos before 1982 and their lung cancer diagnosis must not be older than the last 12 months. Most importantly of all they must be able to get specific about how they were exposed to asbestos in the navy or at work.

High-risk work groups for exposure to asbestos in Wisconsin include US Navy Veterans, a worker at one of Wisconsin's numerous power plants, pulp, or paper mill workers, manufacturing workers, public utility workers, plumbers, electricians, welders, millwrights, boiler technicians, insulators, auto mechanics, machinists, or construction workers. Typically,



the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.
