High-risk work groups for exposure to asbestos now living in Florida include US Navy Veterans, power plant workers, shipyard workers, oil refinery workers, steel mill workers, miners, manufacturing workers, public utility workers, plumbers, welders, electricians, auto mechanics, machinists, or construction workers. Most people who are diagnosed in Florida were probably exposed to asbestos in the Northeast or Midwest. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.
