"An employer cannot simply deduct earned tips from an employee's wages," said Akopyan and revealed, "According to Labor Code Section 351, an employer must pay the employee the full amount of the tip that the customer left for the employee."

Employers cannot deduct credit card processing fees or charges from tips received by employees. Additionally, because tips are left by customers and are not paid by employers, they do not count towards hourly wages and employers can't consider tips a part of the regular pay.

"An employer cannot take any part of a tip and cannot deduct tips from wages," highlighted Akopyan and said, "Employees working in Southern California who feel that they their earned tips may have been fully or partially taken by their employers are welcome to contact Akopyan Law's employment law attorneys in Burbank to discuss their potential case in a complimentary case evaluation."
