

## (Video) Iranians Protesters Confront MOIS Show Outside Hamid Noury Courthouse in **Stockholm**

The protesters chanted: "Murderer of Abadan, your trial is coming", "Mullahs" embassy, this spy den must be shut down", "mercenaries must be expelled".

expelled", and "1988 murderer, your trial is coming".

The gathering was in protest of an exhibition set up outside the Stockholm courthouse by the notorious Habilian Association, a branch of the Iranian regime's Ministry of Intelligence (MOIS).

Eleven MEK supporters were arrested for confronting the mercenaries of the MOIS outside the court where Hamid Noury was tried. They were released at 15:30, Stockholm time. One of the arrestees was injured in a confrontation with the mercenaries and was taken to the hospital by the police.

The three mercenaries and terrorists in charge of organizing the exhibition, arrived in three cars, panicked at the presence of the Iranians, and posted some of their placards and photos in defense of Hamid Noury and against the MEK at a street corner.

The startled mercenaries, being protected by the police, packed up their show ahead of time and

left.

The demonstrators once again called on the Swedish government to arrest, prosecute, and deport agents and mercenaries of the MOIS and the terrorist Quds Force, and to revoke their citizenship and passports, as their sole mission is to spy and facilitate terrorist acts.

The protesters have exposed the crimes of the regime, especially Raisi, the 1988 executioner.

The cowardly plan to hold an exhibition outside the courthouse on Thursday, June 9, and Friday, June 10, by the Habilian Association, was a bid to support the criminal Hamid Noury by echoing nonsense defamation by the mullahs' media against the <u>People's Mojahedin</u> <u>Organization of Iran (PMOI / MEK)</u>.

Aware of the Iranians' acute disgust with the regime and its mercenaries and criminals, the exhibition was kept secret

in advance.

Yesterday (Wednesday, June 8), MEK supporters learned of the exhibition and called on responsible and freedom-loving Iranians to appear outside the court at 10:00 AM today, June 9, to echo the message of the 1988 massacre martyrs and the voice of the Iranian people.

Following protests by MEK supporters and freedom-loving Iranians in Sweden against today's show organized by the mullahs regime's Ministry of Intelligence (MOIS) outside the court where Hamid Noury was tried, the regime's mercenaries were forced to pack up and leave.

In their protests, the freedom-loving Iranians chanted, "MOIS mercenary, get lost!", "Murderer of Abadan, your trial is coming", "Mullahs' embassy, this spy den must be shut down", "(regime's) embassy mercenaries must be deported". As a show of protest, some Iranians spray-painted the mercenaries' car.

Several placards of the MOIS mercenaries were torn during the protest.

The MOIS hired two non-Iranian mercenaries to place their placards and posters, in addition to a person named Shayan, a well-known mercenary who was present at the scene yesterday.

It is noteworthy that the two hired mercenaries left the scene after an hour, and Shayan was the only person on the scene for the regime. This is an indication of the level of revulsion felt for the regime.

During the protest, 12 protesters were arrested, nine of whom had been released by the time this statement was issued.

For the second day, a large number of Iranians gathered this morning outside a courthouse in Stockholm, where Hamid Noury was tried and protested against the ridiculous show of the Iranian regime's Ministry of Intelligence (MOIS) mercenaries outside the court.

They chanted: "Murderer of Abadan, your trial is coming", "Mullahs' embassy, this spy den must

be shut down", "mercenaries must be expelled", "1988 murderer, your trial is coming".

Fearing the powerful presence of the Iranians, the MOIS and its infamous branch, the Habilian Association, employed two recruited non-Iranian mercenaries to place placards and posters in addition to Shayan, a wellknown mercenary who was present at the scene yesterday.

The police moved the mercenaries and their show away from the court and protected them. However, responsible and freedom-loving Iranians disrupted this ridiculous show, tore apart their placards, and spray-painted their cars.



The demonstrators once again called on the Swedish government to arrest, prosecute, and deport agents and mercenaries of the MOIS and the terrorist Quds Force, and to revoke their passports, as their sole mission is to spy and facilitate terrorist acts.

The mercenaries' attempts to set up again their show were futile, and the two hired mercenaries left an hour later. Ten MEK supporters and Iranians were arrested outside Hamid Noury's for confrontation with the mercenaries.

The demonstrators once again called on the Swedish government to arrest, prosecute, and deport agents and mercenaries of the MOIS and the terrorist Quds Force, and to revoke their citizenship and passports, as their sole mission is to spy and facilitate terrorist acts.

The security of refugees in Sweden requires such a measure.
