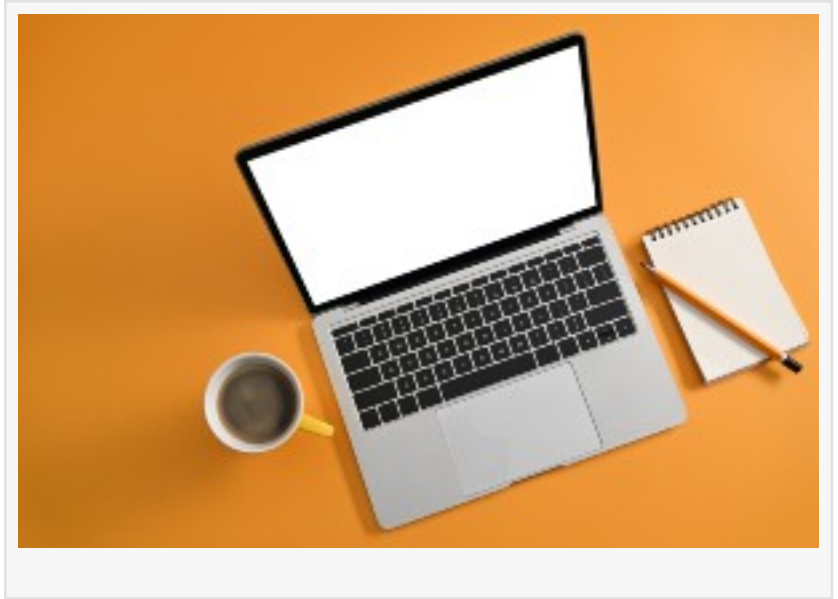


Tampa Bay Bankruptcy Attorney's Advice Featured in Consumer Bankruptcy Journal

In the article, Geller and his co-author [Igor Roitburg, Managing Director of Stretto](#), compares the modification program to a traditional Chapter 13 bankruptcy filing. He points out that Chapter 13 isn't always the best option for dealing with mortgages, sharing the Harvard Business Law Review statistic that about three-quarters of Chapter 13 filers eventually lose their homes within three years of filing.

He points out, though, that spending money on a modification program only makes sense for homeowners who cannot reach their financial goals through other means. Modification programs can be expensive.

However, Geller notes, while the initial cost to participate in a mortgage-modification program may be high, especially for those with financial struggles, he considers it "... an investment worth making to save money and avert even greater financial burdens down the road."
