In particular, the firm actively seeks clients who are 23 or younger and their families and whose social media use has led to physical harm. Examples include: suicidal ideation and action, eating disorders, sexual exploitation, and self-harm.

"Our children are being subjected to constant harassment and abuse on these platforms. As a result, their mental and physical health is at risk like no other time in history," said Darrell Castle, founder and lead attorney at Darrell Castle & Associates. "These companies have a legal and moral obligation to do better. Moreover, the families they harmed deserve justice. We intend to hold the social media giants accountable for their inaction."

The suit seeks damages for the harm caused to children as a result of the companies' failure to protect their mental health. It will focus on children 23 and younger who have experienced physical harm as a result of social media use.

"It's time for these companies to step up and take responsibility for the harm they're causing to our children," said Castle. "We hope this lawsuit will bring about much-needed change and finally help protect the mental health of our youth."
